## Terms and Conditions, page 1 of 3

### DESTINATION WORKSHOP RATES

**"Destination Workshop Tuition"** refers to your total tuition minus any discounts applied at the time of registration (varies depending on room level and double/single occupancy). Availability of workshop spaces and rooms is limited. Rates are guaranteed at time of deposit.

The Destination Workshop price includes items delineated as included in the itinerary and does not include air travel, airline fees, baggage fees, airport or departure taxes, passport fees, additional meals or excursions, and other incidental charges.

### Deposit

A \$1000 deposit (\$500 nonrefundable) is due with your reservation.

### Final Payment

The balance is due 60 days before departure: August 20, 2023.

### Cancellation and Refund Policy

If you need to transfer or cancel your Destination Workshop for any reason prior to the start date, the following cancellation fees will be assessed:

- More than 60 days prior to departure: A \$500 cancellation fee will be retained.
- 59 - 30 days prior to departure: Only 50% of "Destination Workshop Tuition" will be refunded.
- 29 - 15 days: Only 30% of "Destination Workshop Tuition" will be refunded.
- 14 days or less: No "Destination Workshop Tuition" will be refunded.

NO refunds or credits will be given for no-shows, late arrivals, early departures, or program dissatisfaction.

Tuition paid to Love of Aging is transferable to another participant at your discretion.

### Cancellation by one party sharing a Double Occupancy Room

Should your roommate cancel, you are responsible for either replacing them or paying the single room rate. Should we have someone on a waiting list for a shared room, we will of course notify you of that option.

### Cancellation or Re-scheduling by Love of Aging

Any person reserving or purchasing any Love of Aging Destination Workshop accepts the condition that Love of Aging Destination Workshop reserves to itself the exclusive right to cancel, re-schedule, or make other adjustments to any scheduled Destination Workshop in any circumstances deemed necessary, including in accordance with operating requirements or circumstances beyond its control. ### Explanation of Responsibilities

#### Documentation and Vaccinations

Each participant is responsible for proper documentation and inoculations that may be required and/or recommended to participate in our Destination Workshop.

A valid passport is required to enter Mexico and re-enter the United States.

#### Covid-19 Protocols:

**Love of Aging requires that all participants be fully vaccinated for Covid-19.** You must have received at least 2 doses of a recognized Covid-19 vaccine (or 1 dose of J&J) at least 2 weeks prior to departure and bring your vaccination card. IMPORTANT: This requirement may be amended closer to departure depending on government and airline regulations applicable in the US and Mexico.

At this time, a Covid-19 test is no longer required to re-enter the US from Mexico. Should that change, Love of Aging will secure an on-site testing service to test all participants prior to departure, assuming you are departing on our scheduled travel date. COVID testing will cost you \$35. Should a participant decide to stay longer in Mexico following the Destination Workshop, they will be responsible for securing their own test.

Covid-19 safety protocols, including indoor masking in stores and restaurants, may still be enforced throughout San Miguel de Allende, and Love of Aging will follow whatever safety guidelines are in place during our destination workshop dates. *Disclaimer: While Love of Aging LLC will follow all legal mandates designed to minimize the risk of COVID-19 infection, it cannot and does not guarantee any participant's safety from contagion.*

#### Participant Health and Well Being

If you sign up for a Destination Workshop, you acknowledge and agree that you are physically well enough to travel and are responsible for your own well being.

While San Miguel de Allende has modern medical facilities and pharmacies, you must bring enough medication with you for the trip.

#### Participants Needing Special Assistance

Casa Angelitos, our workshop location in San Miguel de Allende, has stairs. It is not wheelchair accessible. In addition, the city of San Miguel de Allende has cobblestone streets and unevenly paved sidewalks.

You must report any disability requiring special attention to Love of Aging at the time the reservation is made. Love of Aging will make reasonable efforts to accommodate the special needs of workshop participants. Such participants, however, should be aware that the Americans with Disabilities Act is inapplicable outside of the United States and facilities outside the United States for disabled individuals are limited. It is strongly recommended that persons requiring assistance be accompanied by a companion who is capable of and totally responsible for providing the assistance.
